FINANCIAL INFORMATION

Seaview Calisthenics College is a not-for-profit organisation that is incorporated as an association for the benefit of members. Our costs have to be met through a combination of fees paid by members and any other funding the organisation can obtain, e.g. from fundraising activities and government grants. In order for our club to remain financially viable, it is essential that all team members pay their share of participation costs. It is the responsibility of the organisation's Executive Committee to determine team member fees and the responsibility of team members to pay their fees on time.

Annual Fees (What you need to pay)

Annual fees calculated for Seaview Team members include:

- Weekly lesson costs (Including hall hire and coach allowance)
- Entry fees for our teams to participate in Calisthenics State Championships
- Other competition fees (Including stage practices, lighting technician fees)
- Costume costs (Including hire and purchases of costumes, trims, costs of repairs and adjustments)
- Equipment costs (Including rods, clubs, stage props, practice skirts)
- Administrative costs (Including website hosting fee, CASA club affiliation fee and RevSport annual fee)

Most of these costs are fixed, i.e. the club still has to pay them, regardless of how many members are present in class. We divide payments of annual fees into 3 Instalments.

You must also pay the Calisthenics Association of South Australia (CASA) registration fee and Australian Calisthenic Federation fee when registering through RevSport. This is paid at the same time as Instalment 1 of our club Annual Fees. The CASA registration fee covers insurance, music licence (copyright fees), theatre maintenance, and administration costs.

You/your child must be registered with fees paid up to date in order to participate in classes. This is essential for insurance reasons and also to make fee payment fair for all members.

Our club offers **Family Discount** of 10% of Seaview instalment fees for second and subsequent participating family members. This discount is applied against Instalment 2.

Our club is registered through the **School Sports Voucher Program**, you can submit one or both of the \$100 School Sports Voucher to be offset against your fees.

We also provide a **Volunteer Credit** of \$10 per session for club assigned volunteer work (e.g. volunteering at our concerts and club events and CASA Royalty Theatre duty)

Fees for each team are calculated based on length of weekly lessons, hall hire, and number of calisthenics items performed (this includes competition entry fees and costume costs).

Payment Information (When to pay)

There are set dates by which Seaview Calisthenics College must make payments to the Calisthenic Association of South Australia (CASA) and other suppliers to enable our members to participate in competitions, maintain insurance and other legal requirements, and cover the costs of costumes, etc.

The Fee Instalment Schedule is designed to ensure that sufficient funds are available from members' fees to cover these costs when they fall due. The Fee Instalment Schedule below shows the amounts you must have paid to Seaview Calisthenics College by the given dates.

Note that RevSport charges a payment processing fee and this is now added upfront so you can see the total charge before proceeding to payment.

Penalties for non-payment of fees

The Executive Committee is responsible for ensuring that Seaview Calisthenics College remains financially viable, participating team members are appropriately registered and insured, and costs are shared appropriately across all team members. Failure to pay your team member fees on time may therefore result in the following penalties:

- removal of non-financial member from the team and exclusion from classes
- exclusion from performing in the CASA competitions/demonstrations
- withholding approval for transfer to another club (this is a CASA rule)
- referral of outstanding fees to a Debt Collection service.

Extenuating Circumstances

We aim to keep our fees lower than other clubs. If you need a Payment Plan, please speak with our Secretary Jenny Pearson, your team coach or another Executive Committee Member.

An alternative Payment Plan may be available if organised at the start of the year – please see an Executive Committee Member if you need an alternative plan. Only the Executive Committee is authorised to alter any individual's agreement or payment plan.

What may not be covered by the Annual Fees

- Bodysuit or other appropriate underwear
- Club uniform (club polo shirt and club jacket)
- Dance shoes (where applicable)
- Competition videos/photos
- Extra practices outside of scheduled lessons (as organised by the team coach)
- Additional activities outside of lessons/competitions/concerts (e.g. team bonding outings, team dinners)

PARTICIPATION INFORMATION AND EXPECTATIONS

Lesson Attendance

Team members are expected to attend lessons weekly at the scheduled time, for the full duration. Please advise the team coach as soon as possible if you/your child is not able to attend. Coaches plan lessons ahead of time and need to know who will be in attendance to ensure lessons run smoothly and changes to lesson plans can be made if needed.

We also expect that team members:

- Arrive on time at the specified lesson time
- Bring water
- Bring necessary equipment including rods, clubs, and aesthetic practice skirt (if required)
 - Your team coach may manage these items instead
- Have hair tied back
- Wear appropriate attire such as a plain leotard, or top and leggings
 - For safety reasons please do not wear baggy/loose clothing and please remove loose jewellery/accessories

Lessons may be cancelled due to extenuating circumstances such as extreme weather or coach unavailability. In these cases, coaches may plan a replacement practice at another time as negotiated with team members/parents.

Coaches will negotiate and advise if practices falling on a public holiday will go ahead or not.

Competitions

We expect that all teams and team members will attend the CASA State Championships each year held in July/August. Please advise your coach as soon as possible if you have concerns over you/your child's ability to participate in these competitions. We can work around important family events and holidays but our coaches need to know well in advance, as this affects team items and choreography.

Coaches may organise to participate in other competitions such as the CALSAC Core Items Competition or other regional competitions. Participation in competitions other than the CASA State Championships is negotiated between the Seaview Executive Committee, the respective team coach/es, and the team members/parents.

Team Facebook Pages

You are invited to join our private Team Facebook group for your relevant team. This is how we generally disseminate information such as reminders, lesson changes/cancellations, practice videos, and additional calisthenics opportunities. The only people permitted to be in these groups and view the content are current registered team members or their parents/carers, the relevant team coach/es, and Executive committee members. Do not share information in these groups with anyone else. This is important for Child Safety and Member Protection requirements. If you do not wish to use Facebook, alternative communication options can be discussed with your team coach.

- I WILL be respectful to all other teams and participants in calisthenics.
- I WILL be a good sport and applaud all other competitors.
- I WILL respect the coaches and adjudicators' decisions- whether I agree or not.
- I WILL tell my Coach or a member of the Executive Committee if I experience bullying or other unwanted or inappropriate behaviour.

CODE OF CONDUCT FOR PARENTS AND CARERS

- I WILL NOT pressure my child in any way – I know that this is their sport not mine.
- I WILL NOT use insulting, discriminatory or derogatory language, nor will I harass team members, coaches, officials or other spectators.
- I WILL remember that children learn best by example so I will applaud good performances for both my child's team and their opponents.
- I WILL focus on my child's efforts and performance – not the placings.
- I WILL give positive comments that motivate and encourage continued effort.
- I WILL help when asked by a coach or committee member.
- I WILL respect the coaches' and adjudicators' decisions- whether I agree or not.
- I WILL teach my child to respect the efforts of others.
- I WILL support and comply with Child Safety and Member Protection policies, including *Working With Children Checks* for volunteers, restricted access to dressing room and backstage areas, restrictions on photography of children, and limitations on disseminating images of children, other than my own, through social media without permission.

TEAM MEMBER AGREEMENT

When you register through the RevSport Portal you will be asked to confirm that you have read, understand, and agree to this Team Member Agreement. This is required to participate at Seaview Calisthenics Club Inc.

- I understand that this document is a legally binding agreement for my child or myself to participate as a member of a Seaview Calisthenics College Inc. team and be registered with the Calisthenic Association of South Australia Inc. (CASA).
- I have read the **Seaview Calisthenics College Inc. 2026 Member Information & Team Member Agreement** document and fully accept and will comply with it.
- I understand that is a condition of remaining in the team that I comply with this Agreement at all times.
- I understand the penalties and consequences should I break any condition.
- I understand that Seaview Calisthenics College Inc. enforce the following codes under the Member Protection Policy and the CASA Rules and I agree to comply with them:
 - The Code of Conduct for Parents and Carers
 - The Code of Conduct for Team Members
- I agree to pay all costs associated with team membership as set out in this Agreement in a timely manner and as determined by the Executive Committee.
- I understand that any absence from lessons for any reason will not result in a refund of fees for those lessons. The Executive Committee may grant leave for extended absence such as for pregnancy of a team member or severe injury or long-term illness.
- I understand that the Coach is the main contact for each team and all communications must be conducted through the coach in the first instance.
- I understand that if I attend a lesson as a participant with an injury or sustain an injury at lesson I must be rested and cannot take further part in that lesson or any further lessons until I am cleared to participate.
- I understand that if I withdraw from the team I am not entitled to a refund of the CASA Registration fee. I may be eligible to receive a partial refund of club fees where costs have not been incurred.
- I agree to abide by Seaview Calisthenics Inc. Constitution, rules, policies, codes of conduct and any decisions of the Executive Committee.
- I also agree to abide by any applicable rules, policies, codes of conduct and decisions of the Calisthenic Association of South Australia Inc. and the Australian Calisthenic Federation.
